### Program Overview

The County of Maui was allocated Community Development Block Grant-Disaster Recovery (CDBG-DR) funds by the U.S. Department of Housing and Urban Development (HUD) in response to the devastating wildfires that occurred in August 2023. On January 21, 2025, HUD published the Federal Register Notice FR-6512-N-01, formally announcing the allocation of CDBG-DR funds to the County of Maui through the issuance of the Allocation Announcement Notice (AAN). The AAN identified the County of Maui as a HUD designated most impacted and distressed (MID) area severity of damage, the level of unmet recovery needs, and other characteristics that exacerbate the impact of the August 2023 wildfires.

The County's Office of Recovery, in coordination with HUD, initiated program planning, community engagement, and the development of the CDBG-DR Action Plan, which outlines the County's recovery priorities and strategies for the use of allocated funds. The Action Plan was developed in accordance with the requirements of HUD's CDBG-DR Universal Notice (FR-6489-N-01), which governs the use and administration of all disaster recovery funds, ensuring consistency, transparency, and compliance with federal regulations.

Following an extensive public comment period, stakeholder consultation, and coordination with federal and local partners, the County of Maui submitted its CDBG-DR Action Plan to HUD for review and approval. HUD approved the County's Action Plan on June 4, 2025, marking a major milestone in the County's long-term recovery efforts. A detailed timeline of Action Planning is outlined below.

### Administrative Action Plan

The County OOR submitted an Administrative Action Plan (Admin Action Plan) on February 21, 2025, to access Program Administrative Costs (PAC's) funding prior to HUD's certification of financial controls, procurement processes, and adequate grant management procedures, as required under the Universal Notice. The County OOR's Admin Action Plan was approved on April 23, 2025.

The Admin Action Plan outlines specific pre-award administrative activities and budgets, ensuring administrative costs do not exceed 5 percent (5%) of the total CDBG-DR allocation.

### Public Action Plan Development

To ensure broad community participation and alignment with local recovery priorities, the County OOR conducted three public meetings to gather input on the County of Maui draft CDBG-DR Public Action Plan:

- Saturday, March 8, 2025; 3 p.m., Princess Nahi'ena'ena Elementary School cafeteria
- Tuesday, March 11, 2025; 3 p.m. online (virtual meeting)
- Friday, March 14, 2025; 5:30 p.m., J. Walter Cameron Center Auditorium

The public-comment period opened on February 24, 2025, and closed at 4 p.m. Monday, March 31, 2025.

The County OOR submitted its draft CDBG-DR Action Plan to HUD on May 09, 2025, and it was approved by HUD on June 04, 2025.

To comply with the Universal Notice, the County OOR CDBG-DR staff completed the following milestones:

- April 3, 2025 – Request for Proposals (RFP) posted for a CDBG-DR Implementation Vendor, resulting in the selection of HORNE LLP through a competitive procurement process.
- June 13, 2025 – HUD approved County OOR's Financial Management Certifications which consisted of the following policies
  - Capacity Assessment and Staffing Analysis
  - Website Maintenance
  - Financial Management, Procurement
  - Fraud, Waste, and Abuse
  - Duplication of Benefits
  - Timely Expenditures.
- Development of the County's CDBG-DR brand: Ho'okumu Hou ("To Rebuild Anew")

With the Action Plan approved, the County formally executed the grant agreement with HUD and began the implementation of CDBG-DR programs designed to address unmet housing, infrastructure, public facilities, and economic revitalization needs. These programs are guided by the principles of resilience, equity, and community restoration, ensuring that recovery investments benefit disaster-impacted residents and foster a more sustainable and disaster-resilient Maui.

The County continues to coordinate closely with HUD, residents, subrecipients, and local partners to ensure compliance with the Universal Notice, 2 CFR 200, and 24 CFR Part 58, as it transitions from planning to implementation and reporting through quarterly performance updates.

#### **Quarterly Performance Report (QPR)**

The first Quarterly Performance Report (QPR) due October 30, 2025, summarizes the progress of the County of Maui Office of Recovery's (OOR) Community Development Block Grant Disaster Recovery (CDBG-DR) Program to date. The County of Maui expresses its deep gratitude to the United States Congress and the United States Department of Housing and Urban Development (HUD) for allocating \$1,639,381,000 in CDBG-DR funding to support Maui's wildfire recovery efforts.

#### **Community Engagement and Planning**

Throughout the disaster recovery process, the County has consulted extensively with disaster-affected citizens, stakeholders, local governments, State and Federal partners, nonprofit and private sectors representatives, and public housing authorities. These efforts, includes guidance from the Mayor's advisory group, were designated to ensure a comprehensive and inclusive approach to identifying and documenting disaster impacts and community needs.

The County recognizes that affected stakeholders are at the center of the recovery effort and serve as key partners in both program design and implementation. Opportunities for citizen participation were provided through multiple in-person and live-streamed public meetings, ensuring accessibility for fire-displaced residents currently living outside Maui County.

The County of Maui's Office of Recovery has launched the Ho'okumu Hou website (<https://hookumuhou.mauicounty.gov/>) as a central, transparent portal to support the recovery efforts funded under the Community Development Block Grant – Disaster Recovery (CDBG-DR) program. This web resource serves a pivotal role in community engagement, ensuring affected residents and stakeholders can access reliable, up-to-date information, submit applications, engage in public input, and track the progress of recovery programs.

On the website visitors will find:

- A description of the Ho'okumu Hou initiative and how it organizes alof the County's CDBG-DR programs, with emphasis on housing assistance for wildfire-impacted survivors.



- Program overviews for major assistance streams (e.g., homeowner reconstruction, reimbursement, first-time homebuyer assistance) including eligibility, application links and downloadable guidelines.
- A “Latest Updates” / news feed section with announcements about upcoming public meetings, updated policies, and fraud-prevention guidance.
- A document library and resource hub enabling users to review the draft and final Action Plan, public hearing material, income limits, fact-sheets, FAQs and more.
- Contact information and in-person resource center locations to support digital access with on-the-ground assistance.

From a performance-reporting perspective, the website plays three key roles:

1. **Transparency and accessibility** – By centralizing program materials, policies, application portals and updates, the site supports compliance with the Citizen Participation and public-input requirements of CDBG-DR.
2. **Community outreach and engagement** – The website complements physical meetings and webinars by offering 24/7 access to information, capturing a broader audience (including those unable to attend in-person). Meeting details and comment-opportunities posted on the site drive broader participation.
3. **Operational streamlining** – The site links directly to application processes, helps track funnel metrics (e.g., number of visits, applications submitted), and provides a follow-up channel for outreach, update notifications, and fraud-prevention communications (e.g., reminding applicants to use only the official site).

The Ho‘okumu Hou website is a dynamic, interactive component of the County’s recovery-communication infrastructure — designed to reach impacted residents, build awareness of the CDBG-DR assisted programs, facilitate access and encourage meaningful engagement through all phases of the recovery effort.

### **Technical Assistance**

The County of Maui has been actively participating in technical assistance (TA) engagements provided by HUD’s designated technical assistance provider, Capital Access, Inc. The partnership with Capital Access has been instrumental in supporting the County’s efforts to build capacity, establish compliant systems, and ensure the effective administration of the Community Development Block Grant – Disaster Recovery (CDBG-DR) grant.

Since the County’s CDBG-DR grant award, Capital Access has provided ongoing technical assistance focused on strategic program planning, policy development, and staff training. These efforts have been closely coordinated with HUD’s Office of Disaster Recovery to align local implementation frameworks with federal requirements and best practices from other grantees nationwide.

Through this partnership, Capital Access has assisted the County in:

- **Strategic Planning:** Facilitating structured planning sessions with the County’s Office of Recovery and its program management team to identify implementation priorities, develop program timelines, and establish cross-cutting coordination mechanisms for housing, infrastructure, and economic revitalization activities.
- **Policy Development:** Providing expert guidance in drafting and refining key CDBG-DR policies and procedures, including those related to procurement, environmental review, subrecipient management, duplication of benefits, and financial controls. These efforts have helped the County formalize consistent and compliant internal workflows in alignment with HUD’s Universal Notice and 2 CFR 200 requirements.
- **Training and Capacity Building:** Supporting the County’s leadership, program management, and departmental staff through tailored trainings and workshops. These sessions have focused on federal grant management principles, internal controls, monitoring, and program design, enabling staff to strengthen operational readiness ahead of large-scale program launches.

The County continues to coordinate closely with Capital Access to ensure that its systems, policies, and procedures meet HUD standards and position the County of Maui’s CDBG-DR programs for long-term success. This ongoing technical assistance has played a critical role in helping the County transition from planning to implementation, while maintaining compliance, accountability, and efficiency in the delivery of disaster recovery resources.

## Program Development and Launch

It is the intent of the County OOR to design and administer all programs in accordance with Federal and HUD regulations, with a focus on long-term recovery, compliance, internal control measures and audit readiness.

On August 11, 2025, the County of Maui officially launched its first two programs under the Ho'okumu Hou initiative: the Single-Family Homeowner Reconstruction and Reimbursement Program (HRRP) and the First-Time Homebuyer Opportunity Program (HOP). These programs represent a major milestone in the County's long-term disaster recovery strategy, funded through the U.S. Department of Housing and Urban Development's Community Development Block Grant – Disaster Recovery (CDBG-DR) program.

In preparation for program launch, the County developed and publicly posted comprehensive program policies and procedures to ensure transparency, accountability, and compliance with federal regulations. In addition, the County established the necessary case management systems, application intake processes, and record-keeping standards to support the efficient administration of all Ho'okumu Hou programs.

Following program launch, eligibility determinations began for applicants to both the HRRP and HOP programs. Early implementation activities have focused on verifying applicant documentation, conducting duplication of benefits reviews, and coordinating environmental review processes required under 24 CFR Part 58.

The County anticipates that home reconstruction activities under HRRP will begin in early 2026, following completion of environmental clearance and contractor procurement processes. For the HOP program, several applicants are expected to achieve first-time homeownership and close on their new homes before the end of 2025, reflecting strong initial program engagement and the County's commitment to accelerating housing recovery for wildfire-impacted residents.

During this reporting period, the County OOR also continued to prepare for the launch of the remaining CDBG-DR programs under the Ho'okumu Hou recovery initiatives.

Key Accomplishments include:

- Financial Management System
  - Implementation of an internal tracking system to align with County fiscal controls and ensure financial transparency.
- Public Communications and Outreach
  - Launch of the Ho'okumu Hou website <https://hookumuhou.mauicounty.gov/> to serve as the primary information hub for CDBG-DR funded programs.
  - Comprehensive outreach campaign across social media, radio, television, digital ads, SMS messaging, and print media to ensure access to information.
  - Translated materials and interpretation services provided in Ilocano, Spanish, and Tagalog, along with accessibility enhancements such as closed captioning and ASL interpreters.
- Community Program Events - Two major public information sessions were held to announce the program launch:
  - Tuesday, July 30, 2025 – Lahaina Civic Center
  - Thursday, August 1, 2025 – Online Community Meeting

At program opening on August 11, 2025, Recovery Intake centers located at the Lahaina Gateway Center in Lahaina and Maui Mall in Kahului opened at 8 a.m. to welcome applicants.

Program results:

- Opening day August 11, 2025: 285 active applications submitted (20 walk-ins at Maui Mall and 50 walk-ins at Lahaina Gateway Center)
- On September 30, 2025 a total of 3,091 applications received which includes:
  - 2,809 applications for HOP
  - 166 applications for HRRP
  - 116 for HRRP Reimbursement

This set-aside ensures recovery for condominium associations impacted by the disaster. For condominium associations, proof must be provided to

demonstrate at least 1 unit in the building is being used as a primary, year-round residence and the building - either residential units or common areas sustained damage as a result of the wildfires.

**Tenant Prioritization:** To the extent feasible, the County encourages its subrecipients and development partners to implement tenant selection preferences that prioritize households displaced by the Maui Wildfires, particularly former renters of lost or damaged units in Lahaina. Final tenant selection policies and procedures will be developed and reviewed by the County of Maui and administered by the subrecipient in accordance with applicable laws, regulations, and CDBG-DR program requirements.

These investments may not qualify under FEMA's hazard-specific definitions but play a critical role in stabilizing housing, infrastructure, and local economies in the face of future threats. Together, these initiatives enable Maui County to strengthen its built environment, safeguard public health and safety, and promote sustainable recovery practices.

**Projects may address:**

- Flood control, wildfire mitigation, fire-resistant infrastructure
- Wind and seismic retrofits for public facilities

- Energy resilience: microgrids, backup power, solar + battery storage
- Water systems: access, distribution, and storage upgrades
- Transportation: mobility, emergency access, transit enhancements
- Housing resilience and affordability
- Parking and access improvements o Development of designated parking areas and related access infrastructure that directly support eligible CDBG-DR projects or facilities (e.g., housing for UN households, public services, or critical community facilities).
- Improvements must be necessary to ensure operational functionality, accessibility, or life-safety access, and may include traffic flow enhancements to reduce congestion and improve emergency response access

**Strategic business relocation and hazard-resilient economic redevelopment:**

- Assistance to eligible businesses in high-risk areas to support voluntary relocation, continuity of operations, and hazard risk reduction through strategic buyouts or site transitions
- The creation or retention of permanent jobs for urgent need individuals

**Priority will be given to:**

- Projects that mitigate wildfire, flood, or storm risks.
- Critical Infrastructure upgrades that enhance community resilience.
- Mitigation measures that protect LMI communities or essential public services.

The County may also offer voluntary buyouts for properties located in high-risk areas, as part of its long-term strategy to reduce future hazard exposure and promote safer, more resilient land use.

**Intended beneficiaries, requirements and prioritizations:**

- Urgent Need Individuals
- Areas or populations that suffered disaster damage and continue to face risk
- Critical community systems (e.g., water) that serve HUD-designated MID areas

Maximum assistance per project will be \$50,000,000.

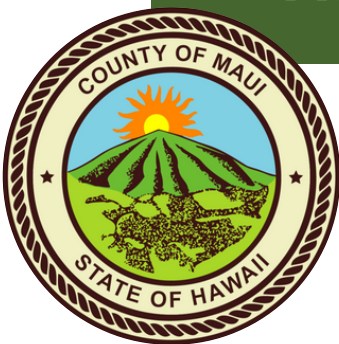

You may be eligible for this program if you:

- Owned a home that was **destroyed by the Maui wildfires**.
- Occupied the home as your **primary residence** at the time of the Maui wildfires.
- Have a household income **at or below 140% of the area median income**



### INCOME ELIGIBILITY

The program will prioritize homeowners displaced by the Maui wildfires while remaining open to all eligible households up to 140% area median income (AMI), with priority given to households with incomes at or below 80% AMI. (See income limits below)

## 1 Submit Your Application



Submit your application online, via the Maui OOR mobile app, or by calling the Ho'okumu Hou Service Center at 808-865-4007.

## 2 Application Assigned to Case Manager



A case manager will reach out to you after your application is received. They will help you through the whole process and work with you to collect all the needed documents.

## 3 Determine Eligibility



Your case manager will review your documents and determine the program you qualify for. Once qualified, your case manager will set up a meeting for you to select the floor plan for your new home.

## 4 Construction



A contractor will be assigned by the program to complete the reconstruction of your home. The contractor will get all the permits and complete construction. Your case manager will keep you updated on construction progress.

## 5 Return Home



After construction is complete, go to the meeting with your case manager, sign all the papers, and get the keys to your new home.



## What are the Terms?

You must agree to live in the home, and if you choose to sell in the future, the County of Maui will have the first right of refusal to purchase it.

With up to \$200,000 in assistance, terms apply for 5 years.  
With up to \$600,000 in assistance, terms apply for 10 years.  
With up to \$1.2M in assistance, terms apply for 25 years.

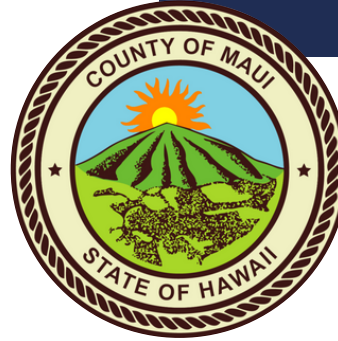

### What are the Terms?

You must agree to live in the home, and if you choose to sell in the future, the County of Maui will have the first right of refusal to purchase it.

With up to \$200,000 in assistance, terms apply for 5 years.  
With up to \$400,000 in assistance, terms apply for 10 years.

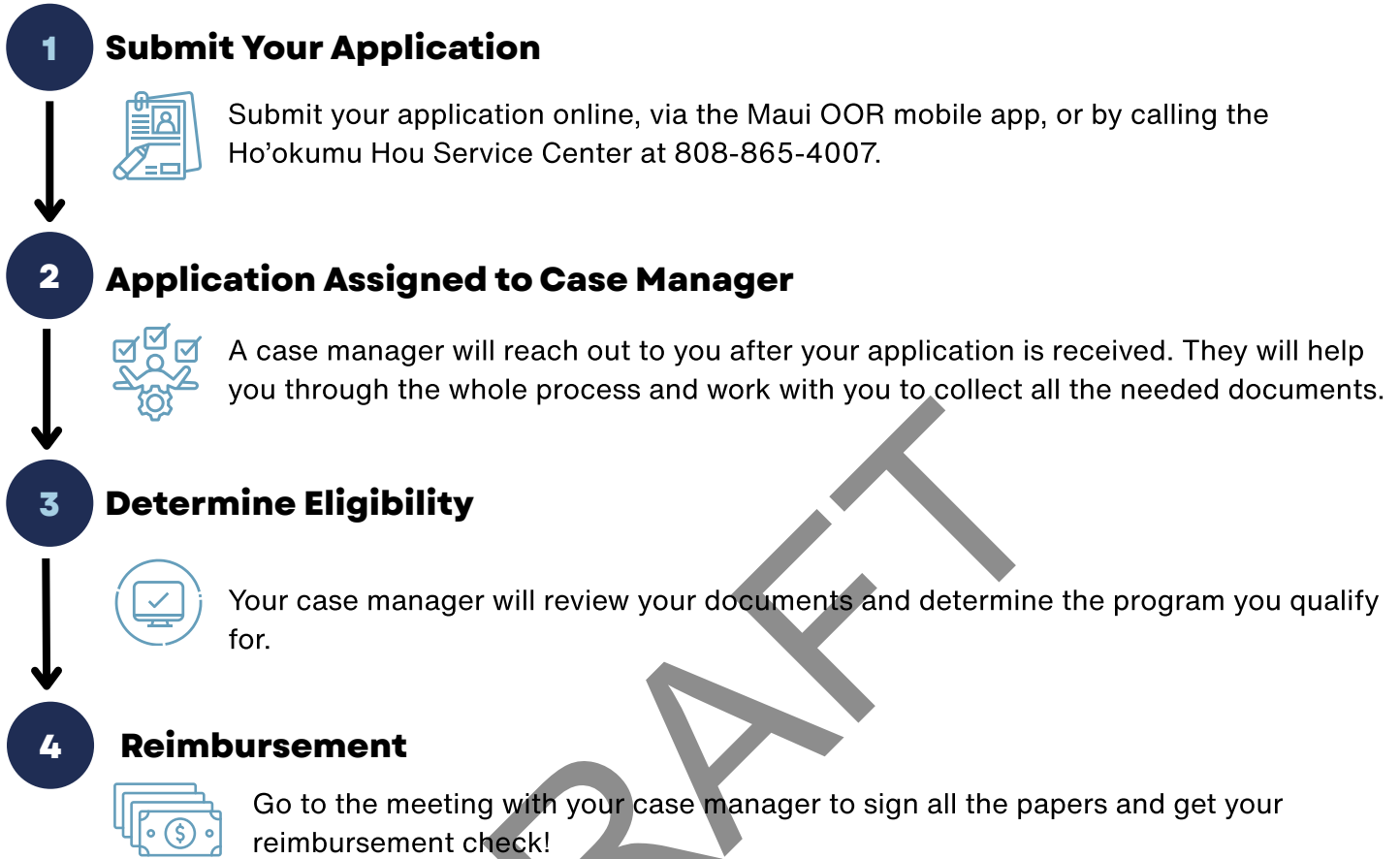

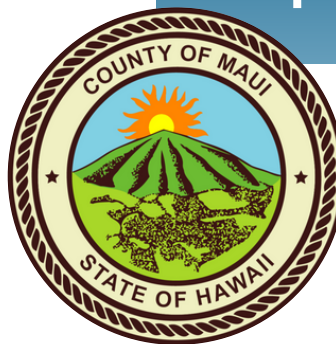

This program helps eligible families with costs like closing costs, down payment help, lowering your mortgage rate (discount points), reducing the loan amount (principal buydown), and other approved expenses for buying a home in Maui County.

## Do you Qualify?

You may be eligible for this program if you:

- **Do not currently own a home**, and have not owned a home within the past 3 years
- Have a household income **at or below 120% of the area median income (see reverse)**



The program will prioritize renters displaced by the Maui wildfires while remaining open to all first-time homebuyers up to 120% area median income (AMI).

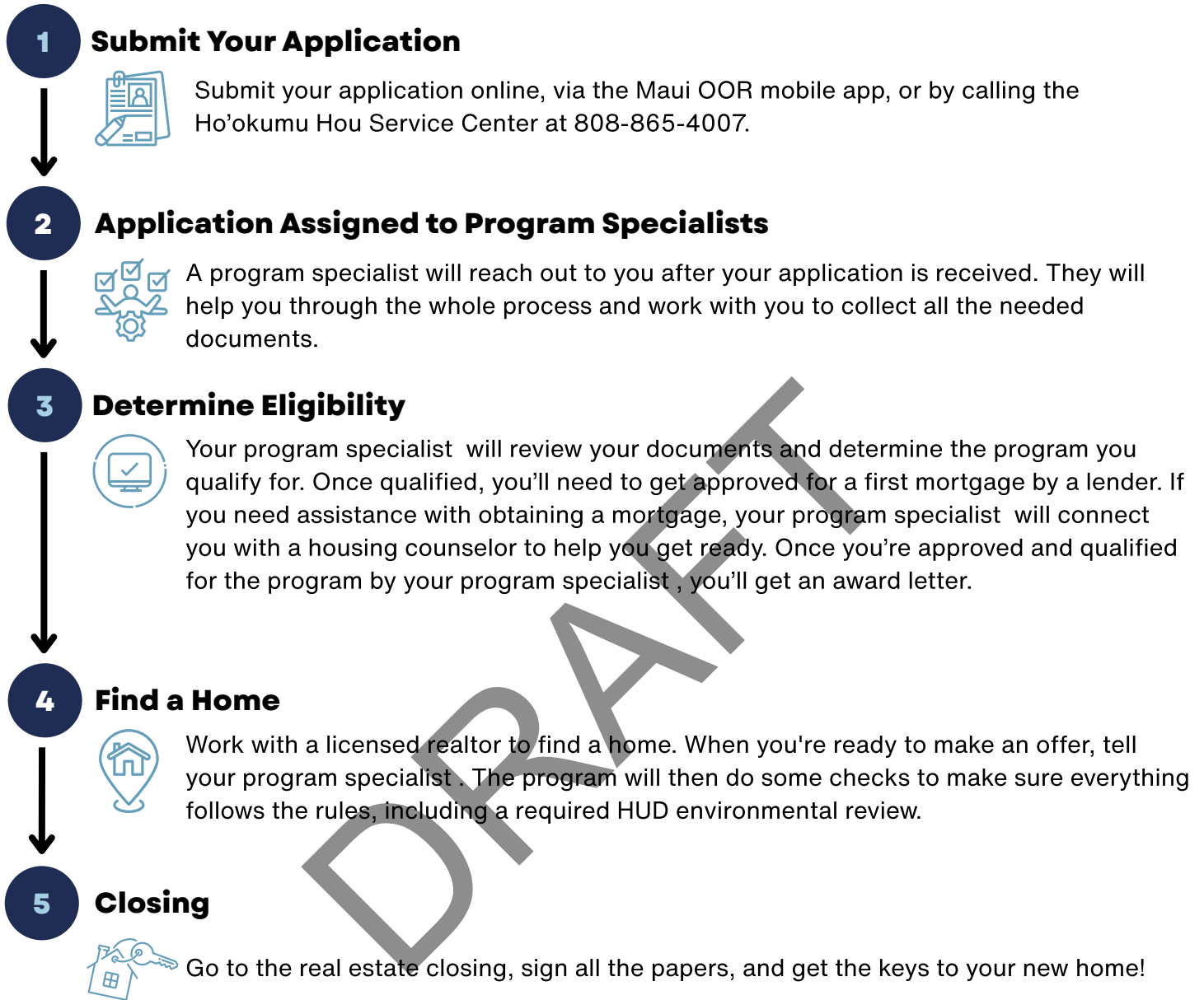
- The amount of help you can get is based on what you need to **keep your housing costs at or below 30% of your household's total monthly income** before taxes.
- You must buy a single-family home, townhouse, or condo in Maui County that is **not in a flood zone**.
- You must agree to live in the home, and if you choose to sell in the future, sell it at an affordable rate to an income-qualified buyer. These terms apply for 99 years.
