



**Notice for Substantial Amendment 1 to  
County of Maui  
Community Development Block Grant Disaster Recovery Action Plan**

In accordance with U.S. Department of Housing and Urban Development (HUD) regulations governing Community Development Block Grant Disaster Recovery (CDBG-DR), the County of Maui Office of Recovery (County OOR) hereby notifies the public that beginning on January 16, 2026, and ending on ~~February 17~~ **March 3**, 2026, public comment will be accepted on the proposed substantial amendments to the CDBG-DR Public Action Plan.
